A minor is a person under the age of 18. Studies the system of social legal, medical and other measures carried out in conjunction with individual preventive work, aimed at identifying and eliminating the causes and conditions that allow the uncontrolled, unattended nature of minors to commit offenses or other social acts by them.

The main tasks of activities for the Prevention of uncontrolled and violations among minors are as follows::

prevention of the occurrence of violations or other social acts by them allows them to identify and eliminate the conditions and conditions:

- ensuring that the rights, freedoms, legitimate interests of minors are protected:

The regulation on Centers for social and legal assistance to minors is approved by the Cabinet of Ministers of the Republic of Uzbekistan.
